

## Dr Katherine Earnshaw: Curriculum Vitae

Dr Katherine Earnshaw (BA MSc PhD) is a Forensic Specialist in Speech & Audio and a Director at the Forensic Voice Centre. She has worked on over four hundred cases, including forensic voice comparison, transcription, questioned utterance analysis and audio enhancement. As an independent expert, she works for both prosecution and defence in criminal cases and she also undertakes work in other types of cases, such as family and civil matters. She produces evidential reports in a wide range of criminal proceedings including fraud, murder, and serious organised-crime cases. She also presents expert testimony in court.

Dr Earnshaw has carried out research on the impact of accommodation on a range of forensic phonetic parameters, and variation in West Yorkshire accents. As part of this work, she was involved in collecting the ESRC funded West Yorkshire Regional English Database (WYRED), which is the largest forensically-realistic voice database containing Northern British English accents. She is a member of several relevant organisations (see below), she has taught sociolinguistics to students at the University of Huddersfield, and she is also an Industry Associate at the University of York where she teaches postgraduates and contributes to research in forensic speech science.
